

# Privacy Policy

Protecting your private information is a priority. This Statement of Privacy applies to [www.pianosensei.com](http://www.pianosensei.com) and Piano Sensei and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Piano Sensei include [www.pianosensei.com](http://www.pianosensei.com). The Piano Sensei website is a Music Instruction site. By using the Piano Sensei website, you consent to the data practices described in this statement.

## Collection of your Personal Information

In order to better provide you with products and services offered on our Site, Piano Sensei may collect personally identifiable information, such as your: First and Last Name, Mailing Address, E-mail Address and Phone Number.

Piano Sensei may also collect anonymous demographic information, which is not unique to you, such as your: Age.

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services available on the Site. These may include: (a) registering for an account on our Site; (b) signing up for special offers from selected third parties; (c) sending us an email message; (d) submitting your credit card or other payment information when ordering and purchasing products and services on our Site. To wit, we will use your information for, but not limited to, communicating with you in relation to services and/or products you have requested from us. We also may gather additional personal or non-personal information in the future.

## Use of your Personal Information

Piano Sensei collects and uses your personal information to operate its website(s) and deliver the services you have requested.

Piano Sensei may also use your personally identifiable information to inform you of other products or services available from Piano Sensei and its affiliates.

## Sharing Information with Third Parties

Piano Sensei does not sell, rent or lease its customer lists to third parties.

Piano Sensei may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to Piano Sensei, and they are required to maintain the confidentiality of your information.

Piano Sensei may disclose your personal information, without notice, if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on Piano Sensei or the site; (b) protect and defend the rights or property of Piano Sensei; and/or (c) act under exigent circumstances to protect the personal safety of users of Piano Sensei, or the public.

### **Tracking User Behavior**

### **Automatically Collected Information**

### **Use of Cookies**

- Exercise free speech, ensure the right of another consumer to exercise his or her right of free speech, or exercise another right provided for by law;
- Comply with the California Electronic Communications Privacy Act;
- Engage in public or peer-reviewed scientific, historical, or statistical research in the public interest that adheres to all other applicable ethics and privacy laws, when our deletion of the

information is likely to render impossible or seriously impair the achievement of such research, provided we have obtained your informed consent;

- Enable solely internal uses that are reasonably aligned with your expectations based on your relationship with us;
- Comply with an existing legal obligation; or
- Otherwise use your personal information, internally, in a lawful manner that is compatible with the context in which you provided the information.

### **Children Under Thirteen**

Piano Sensei collects personally identifiable information from children under the age of thirteen. Piano Sensei collects this information for the following reason(s): when a parent enrolls their child, we collect their age, hobbies, and musical background so we can understand more about them and place them with an appropriate instructor.
